## Premier Plus - Extra!

For a limited period only, clients contributing higher level premiums to Premier qualify for Premier Plus Extra status.

Plans started with a minimum of US\$2,000 per month enjoy an extra 1.5% allocation per year of the Plan's term, up to 15 years. This means that with Premier Plus you can benefit from up to **132.5%** allocation. This additional allocation applies to the full Initial Unit period.

### WHAT DOES THIS MEAN IN REAL TERMS?

Simple: we invest more for you.

#### Example

If a client invests US\$2,000 per month into Premier with a contract term of 15 years, the allocation would be  $110\% + 22.5\% = 132.5\%$ . So for US\$2,000 contributed, there is US\$2,650 working – buying units in your chosen investments.
